DEFINITIONS

The following waste definitions are from the NJDEP. These waste type guidelines are followed by our inspectors:

13 - BULKY WASTE: Large items of waste material, such as appliances and furniture. *Discarded automobiles, trucks, trailers & large vehicle parts are included under this category but are not acceptable at our facility.*

13C - CONSTRUCTION AND DEMOLITION WASTE: Waste building material and rubble resulting from construction, remodeling, repair, and demolition operations on houses, commercial buildings, pavements and other structures. The following materials may be found in construction and demolition waste: treated and untreated wood scrap: tree parts, tree stumps and brush; concrete, asphalt, bricks, blocks and other masonry: plaster and wallboard; roofing materials; corrugated cardboard and miscellaneous paper; ferrous and nonferrous metal; non-asbestos building insulation; plastic scrap; dirt; carpets and padding; glass (window and door); and other miscellaneous materials; but shall not include other solid waste types.

27 - DRY INDUSTRIAL WASTE: Waste materials resulting from manufacturing, industrial and research and development processes and operations, and which are not hazardous in accordance with the standards and procedures set forth at 7:26G (For a complete scope of rules and regulations stated in this statute, please log on to: www.state.nj.us/dep/dshw/resource/njac726g.pdf). Also included are non-hazardous oil spill cleanup waste, dry non-hazardous pesticides, dry non-hazardous chemical waste, and residues from the operations of a scrap metal shredding facility.

DIRECTIONS TO THE FACILITY

From the New Jersey Turnpike Northbound or Southbound:

Take Exit 10 Metuchen and follow signs for Rte 440 N-Perth Amboy. Take Rte 440 to the Industrial Ave/Smith St exit. **Follow all signs for Crows Mill Rd, Keasbey. On the exit ramp, stay to the left until you get to the first traffic light. Make a right at light onto Crows Mill Rd. Cross 2 sets of RR tracks, follow green fence on left to Bayshore's white brick entrance driveway on the left #75.

From I-287 Southbound/Route 440 Northbound:

Take I-287 South which becomes Route 440 North. Pass the Turnpike and Woodbridge exits. The next exit is Industrial Ave/Smith St. Exit here. **Follow directions above.

From Route 9 Northbound & Garden State Parkway North:

Follow Rte 9 N or GSP N. Stay in the extreme right lane as you go over the Edison Bridge or Driscoll Bridge. Take exit for 287 N, Industrial Ave. Go to left, and then to the right on Industrial Ave. First, you go under an overpass and then you will go over 287. ***On the left there is a median in the middle of Industrial Ave. There will be a bus company on the left in the median. Immediately after the bus company, there is a U-turn in the middle of the road. The first one is labeled "Do Not Enter" the second one has a stop sign. Across the roadway on left there is a large warehouse labeled "1000 Industrial Ave." and a small sign for Bayshore Recycling. Stay to the right, and follow the sign for Rte 9 N - Smith St. Make a right at traffic light onto Crows Mill Rd. Cross 2 sets of RR tracks, follow green fence on left to Bayshore's white brick entrance driveway on the left #75.

From the Outerbridge Crossing:

Cross over bridge approximately 2.5 miles. When you see the sign for Industrial Ave, take the exit after the sign (it is not marked). Stay in the right lane. Follow all signs for Industrial Ave. Once you are on Industrial Ave change to left lane. ***Follow directions above.

From Routes 1&9 Southbound:

At the Rte 1 & 9 split, bear left on to Rte 9 S toward "Shore Points/The Amboy's". Take exit that says "Industrial Ave". Exit is under bridges. ***Follow directions above.

Registration Procedure Prior to Dumping

Complete and return attached vehicle enrollment and registration form.

Send copies of the following documents:

- Cab Card for each vehicle enrolled
- A-901 license
- Certificate of insurance naming Montecalvo Disposal Services, Inc., its employees and agents as additional insured. All vehicles must be covered by liability insurance of at least \$500,000/\$1,000,000 and \$100,000 for property damage or a combined single limit of \$1,000,000. All operators must be covered by a worker's compensation program.

All accounts are prepaid. Deposits for disposal will be based on estimated/anticipated tonnage to be disposed on a weekly basis.

There will be a minimum of \$2,500 deposit to set up an account or you must make other arrangements in advance.
